- Held a Mindfulness in Medicine Retreat in April. The Mindfulness in Medicine Retreat was a two-day intensive workshop led by local stress reduction educator and licensed clinical therapist, Scott MacGregor. Scott was joined by Dr. Dael Waxman of the Carolinas Health System. Dr. Waxman has specialized training in mind-body medicine and incorporates those modalities into his medical practice. The two-day event focused on the topics of mindfulness, resilience, narrative medicine and appreciative inquiry. Attendees received 13 hours of CME. There were 12 attendees.  
- Strongly opposed SB 629 regarding Health Care Services Billing Transparency, which calls for a benchmark fee for any service provided to a patient by an out-of-network provider if an in-network provider is available to meet the patient's needs without unreasonable delay.

- Held a Healthy Healer Retreat in November called Medicine and Family: New Challenges; New Solutions. Noted speaker Rebecca Fallon of the Sotile Center for Resilience and Center for Physician Resilience, shed light on the inner workings of contemporary medical providers and their families who manage to have it all: productive careers, high levels of collaboration and collegiality in the medical workplace, and thriving personal lives. Drawing material from the Sotile's books, over 15 years of clinical and consulting experiences, and her practice's ground-breaking research with medical families, Rebecca focused on practical strategies that can immediately make a difference in your work and family relationships, regardless of how you define "family." There were 40 attendees.  
- Held 11 affinity groups throughout the year.

- Interviewed 4 different innovative practices in the region and shared their inventive ideas with members. The interviews were with Drs. Scott Donaldson and David Ellis at Pardee Hospital, Dr. Jeremiah Mason at Surgical Specialists of Carolina, Dr. Lynn Dressler at Fullerton Genetics Center, and Dr. Claudine Siegert at Blue Mountain Surgery.  
- Supported the Strengthen Opioid Misuse Prevention (STOP) Act.  
- WCMS and 5 physicians went to Raleigh for White Coat Wednesday and met with several WNC legislators.  
- Supported HB 662: Carolina Cares, which increases healthcare options for many North Carolinians left uninsured.  
- Recruited 80 new members to WCMS, and renewed 610 members from previous year.
