Foundation Accomplishments
In 2018 the Foundation facilitated services to almost 2,000 patients by over 500 physicians with an estimated value to the community of over \$5,033,132 million. Of those served, over 700 were new patients.
Enrolled 25 consumers into the Health Insurance Marketplace.
WCMS Interpreter Network (WIN) had over 8,400 appointments (9% growth compared to 2017) helping limited English-proficient and Deaf patients communicate with their providers.

The WCMSF Endowment provided an \$8,000 grant to support The Free Clinics of Henderson County to expand a health program that will provide an alternative home for vulnerable patients with chronic medical conditions, behavioral health concerns, or severe economic deprivation. They also provided a \$740 grant to Sixth Avenue Psychiatric Rehabilitation Partners (dba Thrive) for clinical supervision and expertise and data collection support for client services.
The Charles Blair Scholarship fund provided small scholarships to six students to pursue a career in health.
